## COMMUNICATING EUROPE CONFERENCE: GERMAN PERSPECTIVES ON ENLARGEMENT

Pajo Avirović is State Counsellor and Director for Public Diplomacy of the Public Diplomacy Directorate at the Ministry of Foreign Affairs in Skopje. He is also the Editor-in-Chief of 'Crossroads', the Macedonian Foreign Policy Journal, and Editor-in-Chief of the Macedonian Diplomatic Bulletin. His diplomatic posts include; Head of the Sector for Bilateral Relations with European Countries (2006 to 2007), and Deputy Head of the Coordination Sector of the Minister's Cabinet (2005 to 2006). He served as Minister Counsellor at the Macedonian Embassy in Paris (2001 to 2005). He was winner in 2005 of Macedonia's top literary prize for his novel, "Jahiz and the Dogs' Exterminators". Pajo Avirović has a Brevet de l'ENA (Ecole Nationale d'Administration) in Paris. He was awarded an M.A. in Oriental Philology, by the University of Belgrade, and a B.A. in Oriental Philology by the University of Sarajevo, where he majored in Turkish Language and Literature, and Arabic Language and Literature.

**Igor Davidović** is the EU Stabilization and Association Agreement Chief Negotiator of Bosnia and Herzegovina and was in charge of the successful negotiations for a Stabilisation and Association Agreement which were concluded in December 2007. Previously, he was the Ambassador of Bosnia and Herzegovina to the United States. In 2005, he was appointed *ambassador at large*. He also served as the Chief of Staff of the Prime Minister of Republika Srpska.

**Albert Gajo** is Albania's Deputy Minister of European Integration and an expert economist. Previously, he was Executive Director of the Research and Development Centre, a non-profit organisation which focuses on economic analysis to help public institutions and the business community in drafting good policies for the encouragement of private sector development. From 1998 to 2002, he was a research fellow and lecturer at Maastricht University, at the Faculty of Economics and Business Administration, where he specialised in the management of resources in transition economies and public finances. From 1992 to 1997, he was economic advisor to the then Albanian Prime Minister.

**Zvonimir Jankuloski** is a University Professor/Dean of School of Law at the University American College in Skopje where he specialises in International Law, Human Rights, Diplomacy, International Relations, and International Public Law. He was a member of the Macedonian negotiation team for the Stabilization and Association Agreement with the European Union. He also served as Ambassador and Permanent Representative of the Republic of Macedonia to the Council of Europe. From 2005 to 2007, Zvonimir Jankuloski was Visiting Professor at the Faculty for Public Administration at Bitola University and a senior researcher in human rights issues at the Institute for Sociological, Political and

Juridical Research, at the University of the 'St. Cyril & Methodius' in Skopje. He was awarded his Ph.D., M.A., and B.A. by the Faculty of Law at the same university.

Arben Kashahu has been Secretary General of the Ministry of European Integration in Tirana since February 2006. He was Director of the Cabinet of the Minister of European Integration, from 2005 to 2006. Previously, he was a Senior Legal Advisor of the Foundation for Local Autonomy and Governance, from 2003 to 2005. He worked as a private Attorney from 2003 to 2005, providing legal expertise for many national and international agencies, private companies and individual clients. He is also a Lecturer in the Faculty of Law at the private University 'Kristal', and at the Faculty of Law at the private 'European University of Tirana'. He was awarded a M.A. in 'Governance and Politics of European Integration' by the University of Bologna in 2003. He was awarded his B.A. by the Jurisprudence Faculty, University of Tirana, Albania in 1999.

**Tanja Misčević** is Director of the European Integration Office in Belgrade. Since 2001, Tanja Misčević has been the Director of the Department of European Studies of the G17 Institute in Belgrade. She initiated and organised the first programmes for training of civil servants on the functioning of the EU. Tanja Misčević has also lectured widely; as a Visiting Professor at the University of Bonn, at the Centre for European Integrations, at the Diplomatic Academy of the Croatian Ministry of Foreign Affairs, and at the Faculty of Economics of the Montenegrin University in Podgorica. She teaches EU Accession Policy at the Postgraduate Studies Centre at the Faculty of Political Sciences (FPS) in Belgrade, where she was also awarded her Ph.D.

**Hedvig Morvai-Horvat** is the Director of the newly established European Fund for the Balkans. It is an initiative of a number of European Foundations including the Robert Bosch Stiftung, the King Baudouin Foundation, the Compagnia di San Paolo and the ERSTE Foundation. The Fund is designed to help European foundations to become more actively involved in South East Europe and to prepare the countries of the region for their future in the EU. Previously, Hedvig Morvai-Horvat was the Director of the Citizen's Pact for South East Europe, a network of NGOs and municipalities throughout the region, aiming to contribute to the development of civil society and stability, in particular through the strengthening of crossborder co-operation and of partnerships between local government bodies and nongovernmental organisations.

Siniša Petrović is member of the negotiating team for Croatia's accession to the European Union. He is currently Professor at the Faculty of Law at the University of Zagreb and teaches Commercial, Corporate and Competition Law. He is also an arbitrator for the Croatian Chamber of Commerce, arbitrator for the Croatian Olympic Committee and arbitrator on sub domains of the .hr web-domain. He was a member of working groups for a number of Croatian legislative projects (e.g. the Companies Act, the Law on Agency on Property Transactions, the Law on the Prevention of Conflicts of Interest, Privatization Act, Competition Law,) and participated in several privatization and investment projects in Croatia. He is the author of several papers and books in the field of commercial law, company law, competition law, sports law and foreign investments. He graduated from the Faculty of Law at the University of Zagreb in 1990, and in 1998 he defended his Ph.D. thesis at the same University.

**Darija Ramljak** is Assistant Director at the Directorate for European Integration at the BiH Council of Ministers. She is Assistant Director for Bosnia-Herzegovina's EU Integration Strategy and Head of the Department for Integration Strategy. She is also a member of the negotiating team for the Stabilisation and Association Agreement.

**Vladimir Todorić** is Adviser to the Deputy Prime Minister, Bozidar Djelić, for legal issues of European Integration. He is also an editor of the Serbian Law Review and regularly publishes articles in magazines and newspapers. He was the co-ordinator of the National Strategy for the EU Accession in 2005; He is also an Assistant Professor at FEFA faculty in Belgrade and is a researcher at the Institute for European Studies. He graduated at the University of Liverpool with a degree in European Union Law.

**Osman Topčagić** is the Director of the Directorate for European Integration of Bosnia-Herzegovina. He is the most senior civil servant in charge of European integration in Sarajevo. From 2002 to 2003, Osman Topčagić was Minister-Counsellor at the Mission of Bosnia and Herzegovina to the EU and to NATO in Brussels. He has also served as Ambassador of Bosnia and Herzegovina to the United Kingdom.

**Nada Vojvodic** is an Adviser at the Secretariat for European Integration in Podgorica. She is responsible for the Communication Strategy to inform the public of Montenegro about the EU Integration process. She works with national and international institutions in providing trainings on EU integration issues, and in preparing promotional and educational material. She is also attending post-graduate studies in public relations. Nada Vojvodic was an adviser to the Ministry of European Integration and International Economic Relations from 2004 to 2006. She was awarded a degree by the Faculty of Political Science in Belgrade in 2003.

**Boris Vujčić** is Croatia's Deputy Chief EU negotiator, and Deputy Governor of the Croatian National Bank. Dr Vujčić's fields of expertise are macroeconomics, international finance and labour economics. He is also a professor at the University of Zagreb, where he was awarded his B.A., M.A., and a Ph.D. in economics. Boris Vujčić has also been external collaborator for the International Labour Organization (ILO) and a consultant to the European Commission.

Ana Vukadinovic has been Head of the Secretariat for European Integration in Podgorica since December 2006. She is responsible for the co-ordination and supervision of the EU association and accession process; preparing the key documents, co-ordinating inter-ministry preparations for the negotiations, and monitoring the process of implementation, co-operation with EU institutions, and EU Member States. Previously she worked as an adviser in the Foreign Ministry from 1999 to 2000, and she was a media monitor and analyst for a range of media organisations, including, ZDF, BBC, Reuters and the OSCE in 1998-99. Ana Vukinovic was awarded a MSc in International Business Management by the School of Management at the University of Surrey in 2005, and a BSc in Financial and Bank Management by the Economics Faculty at the University of Montenegro in 1999.

Andrej Zernovski is the Parliamentary Co-ordinator, and Vice President, of the opposition Liberal Democratic Party in Skopje. He is a member of the Committee on Issues of the European Union at the Federal Assembly of the Republic of Macedonia. He was Co-chair of the EU Committee in the previous election period until 2006. Mr Zernovski currently is also a deputy member of both the Foreign Policy and Defence Committees. He is a member both of the Joint Parliamentary Committee-EU - Republic of Macedonia, and of the Parliamentary Group of the Assembly for Co-operation with the German Federal Parliament. He graduated with a degree from the Faculty of Civil Engineering in Skopje.
